RELEASE AGREEMENT

- 3) The Model acknowledges that participation is voluntary with no financial compensation of any type and that the use of photos and/or videos confers no rights of ownership or royalties.
- 4) Use of the Work shall be unrestricted as to location, quantity, or frequency, may be for any purpose and in any medium, whether foreseen or unforeseen at this time, except where such use is in contravention of the law.
- 5) Permission is specifically granted for the Work to be edited, altered, or used in whole or part, or in conjunction with other images or graphics without restrictions.
- 6) Permission herein granted is absolute and final and shall not be subject to further inspection or approval by the Model at any state in the use of the Work.
- 7) Use of the Work may be in conjunction with the Model's own or fictitious names.
- 8) With full knowledge of the above, the Model hereby releases and shall hold Eastwood, its contractors, its employees, and any third parties involved harmless from all claims or damages, including but not limited to defamation or violation of privacy or publicity, portrayal in a false light, false endorsement, or any other claim(s) based on use of the above-described material(s) or Model's name, likeness, persona, appearance, and/or voice resulting from or associated with the use of the Work.
- 9) The Model agrees that the provisions contained herein shall be binding upon the Model and his/her successors, legal representatives and assigns.
